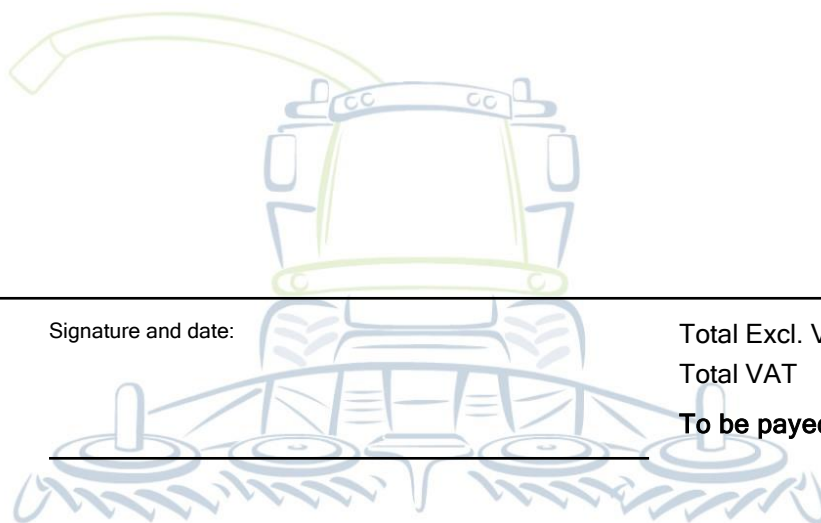

- the buyer has the right to inspect the goods at his own expense. Buyer accepts the goods in the condition at the time of the inspection.
- purchased goods can not be exchanged or returned.
- there is no warranty applicable to the goods sold and delivered.

Payment:

10% down payment within maximum 7 days after the proforma invoice date.

If no down payment is received from Client after day 7, Contractor has the right to sell the goods to another party. All rights of the Client lapse, the sales agreement is no longer valid.

Full payment within maximum 28 days after the proforma invoice date.

If no full payment is received after day 28, the down payment and the full purchase agreements with the Client will be cancelled. Contractor has no obligation to refund the Clients down payment and has the right to sell the goods to another party.
